## A General Terms

### 0 Validity

This Schedule of Prices and Services is valid as of September 7th 2017. It replaces the Schedule of Prices and Services PM 103 dated March 2016. Information about changes and amendments will be announced in the journal "**VDE** *in focus*" before they come into effect and published in the VDE Institute by notice on the notice-board and on the Internet at [www.vde-institut.com](http://www.vde-institut.com). Upon request we will send the actual version.

### 1 Tests

- 1.1 All kinds of tests will be charged according to expense.
- 1.2 For the **certification test** of a product according to an **international or European certification procedure** (CCA, CB, ENEC), a surcharge depending on the kind of product will be charged.

### 2 Certifications

- 2.1 For **certification / validation** of tests an amount according to section B11 will be charged. This applies to the review for the certification process and to the validation of test results as well as to the information about negative test results, to written expert opinions, to CB/CCA/ENEC certificates or to test reports for customer information.

In case of retesting of a product and conformity control tests this amount will not be charged.

- 2.2 The **certification** of a product (for example by issuing a VDE marks approval) when presenting a certificate issued in accordance with an **international or European certification procedure** and additional tests according to requirements differing from international or European standards will be charged according to extent and expense.
- 2.3 Annual fees will be charged for each marks approval. They are calculated by multiplication of the annual fee units - determined for each approval - and the value given in section B 8.
- 2.4 An annual basic fee according to clause B 9 shall be paid for each place of manufacture. For approvals type B no annual basic fee will be charged.

2.5 A sales-permission for the sale of remaining stock can be issued, if a legal basis is existing. The permission will be generally granted for two years. The price will be calculated by multiplication of the annual fee units and the value given in section B 8. It will be charged with the issue of the permission itself. The sales-permission will expire automatically at the end of the validity period.

2.6 For an existing marks approval based on a test according to clause A 1 or a certification according to clause A 2.2 (referred to as type A in the following), further approvals for additional trademarks can be issued:

- **Marks approval type B:**

Marks approval for a further approval holder, who marks his product only with his own trademark.

Conditions: The approval holder of the marks approval type A agrees and declares the identity of the products.

Costs: The same annual fees as for marks approval type A, costs for issuing the marks approval (section B 12 b).

When a marks approval type A expires, the marks approval type B expires, too.

2.7 Annual fees will be charged for the first time starting from January of the following year after a marks approval has been issued. For marks approvals type B as well as for harmonized cables and cords annual fees will be charged immediately.

2.8 Annual fees are due in advance at the beginning of each calendar year.

### **3 Inspections, QM System Audits and Testing at manufacturers premises**

3.1 Inspections, QM System Audits, conformity assessment procedures and testing at manufacturers premises will be charged according to expense.

## 4 Other Tests and Services

Other Tests and Services, for example:

- Training
- Assessment of protection concepts
- Assessment of technical documentation
- Assessment of instruction manuals
- Check of electrical equipment
- Energy efficiency and usability tests
- Battery and environmental audits
- Pre-shipment controls
- Risk analysis
- Safety standards service
- Expertises

will be charged according to expense.

## **B Basic Prices**

- 1 The prices listed below and all offered or invoiced prices are net prices. These net prices are increased by the legally valid value added tax (VAT) or any applicable foreign tax (i.e. “China Business Tax”, withholding tax, taxes due to non-resident taxation,...) in the statutory amount at any one time.

Foreign taxes and other charges of any kind shall be calculated and strictly borne by the invoice recipient as long as according to a foreign law the obligation to deduct tax is stipulated. They do not reduce the amount due to VDE Institute.

The approval holder, the customer and the invoice recipient are jointly and severally liable for the correct calculation and payment of foreign taxes and other charges and have to indemnify upon first request VDE Institute from any loss or damage that result from failure of the party liable for payment to fulfill tax duties.

Payments are due upon receipt of the invoice without deduction.

Test reports are generally written in German or English. Translations will be charged according to expense.

- 2 If in one order various services of the VDE Institute are required at the same time, this order may be calculated according to the reduced amount of work (package - prices).
- 3 If co-operation partners are involved, special rules may become effective.
- 4 In some regions, subsidiary companies of the VDE Global Services GmbH or VDE authorized partners are installed in order to simplify and speed-up the handling of orders. The addresses are published on our website [www.vde-institut.com](http://www.vde-institut.com). Due to higher handling-costs in some countries, a surcharge will be charged, if the applicant is located in one of those countries.<sup>1</sup> The surcharge is not due on annual fees according to clauses A 2.3 to A 2.8 and the fees for Certification / Validation according to clause A 2.1.
- 5 Services to obtain certificates and other services from other organisations are generally charged according to expense. At present, agreements are existing with testing organisations in Argentina, Australia, Belorussia, Brazil, Canada, China, Japan, Kuwait, Poland, Republic of Korea, Russia, Saudi Arabia, Ukraina, USA, and all other countries participating in CENELEC and IECEE.
- 6 The quoted prices are valid for three months from the date of the offer.
- 7 Costs, e.g. for energy, will be charged separately.
